ARTICLES OF INCORPORATION

DISABILITY RIGHTS ACTION COMMITTEE OF UTAH

Article 1. Name: The name of the corporation is the Disability Rights Action Committee of Utah.

Article 2. Duration: The period of duration of the corporation is perpetual.

Article 3. Purposes: The purpose of the corporation is:

a) to organize, provide environmental and support alternatives for the disabled.

b) to educate, empower and advocate for the disabled person in Utah, as well as the general public, on problems and issues relating to the disabled, including the rights of the disabled under federal and state laws regarding housing, employment, public accommodations, public transportation, and other disability issues.

c) to assist persons who are disabled to ascertain their fullest potential as citizens of the United States of America and the State of Utah.

Article 4. Type of Corporation: The Corporation shall be organized as a non-profit corporation, shall not issue shares of stock and may have members. This corporation is organized exclusively for charitable and educational purposes within the meaning of section 501(c)(3).

"Notwithstanding any other provision of these articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any future United States Internal Revenue Law) or (b) by Corporation contributions which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 (or corresponding provision of any future United States Internal Revenue Law)."

No part of the net earnings of the Corporation shall inure to the benefit of or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in any political campaign on behalf of a candidate for public office.

Upon dissolution of this Corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future tax code), or shall be distributed to the federal government, or state and local government for a public purpose. Any such assets not so disposed of shall be disposed by a Court of Common Pleas of the county in which the principle office of the Corporation is then located, exclusively for such purposes or to such organizations as said Court shall determine, which are organized and operated exclusively for such purposes.





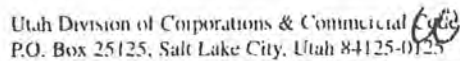
