We, the undersigned, natural persons over the age of twenty-one (21) years, acting as incorporators of a non-profit corporation under the Utah Nonprofit corporation and Cooperative Association Act and the several amendments thereto do hereby set forth

ARTICLE I NAME

The name of this nonprofit corporation shall be

EAST BENCH COMMUNITY COUNCIL

ARTICLE II DURATION

This corporation shall continue in existence perpetually unless dissolved pursuant to law

ARTICLE III PURPOSE

This corporation is organized as a nonprofit corporation and shall be operated exclusively for the promotion of social welfare. Within the scope of the foregoing purpose, the specific pursuits and objects of this corporation shall be to exercise, promote and protect the privileges and interests of owners of the real property located in the area bounded on the north by 1300 South, on the west by Foothill Boulevard, on the south by Interstate 80, and on the east by the Salt Lake City Eastern Foothill boundary, situated in Salt Lake County, State of Utah, to promote cooperation among the property owners, to provide recreational facilities for the property owners, and generally to promote the community welfare of said property owners. This corporation shall not carry on, otherwise than as an insubstantial part of its activities, activities which are not in furtherance of one or more of the aforementioned purposes for which the corporation is organized.

ARTICLE IV MEMBERS

The qualifications of members of the corporation, the property, voting and other rights and privileges of members, and their liability for dues and assessments and the method of collection thereof, shall be set forth in the By-Laws

A <u>Powers in General</u> Subject to the purposes declared in ARTICLE III and any limitations herein expressed, this corporation shall have the power to do any and all things which a nonprofit corporation may do under the laws of the State of Utah

B Powers Relating to Specific Objects and Purposes This corporation shall have the powers necessary or incidental to the carrying on of its objects and purposes, including but not restricted to discharging the intent and desires of its creators in promoting the community welfare of the property owners located in the area described in ARTICLE III, Salt Lake County, State of Utah

ARTICLE VI PRINCIPAL PLACE OF BUSINESS

The initial principal place of business of this corporation shall be 2384 South Summit Circle, Salt Lake City, County of Salt Lake, State of Utah, and branch places of business may be established and business conducted at other places in the State of Utah or elsewhere as the Trustees may from time to time provide

ARTICLE XIII DISSOLUTION

This corporation is one which does not contemplate pecuniary gain or profit to the members thereof and it is organized solely for nonprofit purposes. Upon the winding up and dissolution of this corporation, after paying or adequately providing for the debts and obligations of the corporation, the remaining assets shall be distributed to a nonprofit fund, foundation, or corporation, which is organized and operated exclusively for charitable, educational, and/or scientific purposes.


