Amendment to the Articles of Incorporation of the Greater Avenues Community Council

ARTICLE IX

PROVISION FOR AMENDMENTS TO ARTICLES OF INCORPORATION

These Articles of Incorporation may be amended by the approval and adoption of a resolution by the Officers and the vote or written consent of two-thirds of a quorum of the members of the corporation. Written consent of such members may be obtained either before or after the adoption of such resolution by the Officers.

ARTICLE X

DISSOLUTION

In the event of the dissolution of the Corporation, after paying or adequately providing for the debts and obligations of the Corporation, the Officers shall dispose of its remaining assets by conveying and transferring the same in any proportion or amount as shall be deemed proper, to any one or more non-profit associations, or corporations, or municipal organizations or divisions thereof, whose aims and purposes shall or may approximate those of this corporation, or which, in the opinion of the Officers, will serve to further the best interests of the persons for whose benefit this corporation was formed and maintained.

ARTICLE XI LIABILITY FOR DEBTS OF THE CORPORATION

Neither the members nor officers of the corporation shall be personally liable for the debts, liabilities or obligations of the corporation.

ARTICLE XII REGISTERED AGENT
