



PROPOSITION INFORMATION PAMPHLET FOR A CITIZENS INITIATIVE

Dear Salt Lake City Resident,

On March 17, 2021, an application for a citizens initiative (the “*Application*”) was filed with the office of the Salt Lake City Recorder. As explained below, an “initiative” is a new law proposed for adoption by the public through a petitioning and verification process which, if successful, can result in the new law appearing on an upcoming ballot for approval or rejection by the voters. The initiative process is governed by Utah state law, which specifies the exact steps, standards and timetables which must be followed by both the proponents of the initiative and the governmental entity.

If this initiative process ultimately is successful under the applicable state statutes, then it is anticipated that the proposed new law will be included on the ballot for the municipal general election scheduled for November 2, 2021.

Utah state law governing the initiative process provides that (a) the citizen “sponsors” of the initiative may provide a written argument in favor of the initiative, (b) the city may provide a written argument for or against the proposed initiative, and (c) the city’s election officer (here, the City Recorder) then compiles, publishes and publicly distributes a written information pamphlet which contains the Application, arguments (if provided), and a fiscal/legal impact statement prepared by the city’s budget officer and attorney. Those items follow as part of this information pamphlet.

SALT LAKE CITY ORDINANCE

**AN ORDINANCE DESIGNATING THE UTAH PANTAGES THEATRE
LOCATED AT 144 SOUTH MAIN STREET AND THE CAPITOL THEATRE
LOCATED AT 50 WEST 200 SOUTH AS LANDMARK SITES THROUGH AN
EMERGENCY PROCEDURE FOR DESIGNATION OF LANDMARK SITES**

WHEREAS, Chapter 21A.34.020.C grants the Salt Lake City Council authority to establish Landmark Sites within Salt Lake City;

WHEREAS, the Salt Lake City Council has failed to initiate any procedure under Chapter 21A.34.020 to designate the Utah Pantages Theatre, located at 144 South Main Street, as a City Landmark Site to be included in the Salt Lake City Register of Cultural Resources;

WHEREAS, the Salt Lake City Council has failed to initiate any procedure under Chapter 21A.34.020 to establish the Capitol Theatre, located at 50 West 200 South, as a City Landmark Site to be included in the Salt Lake City Register of Cultural Resources;

WHEREAS, the Utah Pantages Theatre is of exceptional importance to the City, State, region, and Nation and imparts high artistic, historic, or cultural values. The Utah Pantages Theatre clearly conveys a sense of time and place and enables the public to interpret the historic character of the Theatre.

WHEREAS, the Capitol Theatre, which is listed on the National Historic Register, is of exceptional importance to the City, State, region, and Nation and imparts high artistic, historic or cultural values. The Capitol Theatre clearly conveys a sense of time and place and enables the public to interpret the historic character of the Theatre.

WHEREAS, the voters of Salt Lake City desire by this Ordinance to designate the Utah Pantages Theatre, located at 144 South Main Street, as a landmark site to be included in the Salt Lake City Register of Cultural Resources;

WHEREAS, the voters of Salt Lake City desire by this Ordinance to designate the Capitol Theatre, located at 50 West 200 South Street, as a landmark site to be included in the Salt Lake City Register of Cultural Resources;

WHEREAS, although the Property where the Utah Pantages Theatre is located is owned by the Redevelopment Agency of Salt Lake City, the Utah Pantages Theatre is in imminent threat of being demolished creating a state of emergency; and

WHEREAS, the voters of Salt Lake City desire to suspend the normal procedures found in Chapter 21A.340.020 of the City Code and utilize the emergency procedure as set forth herein to designate the Utah Pantages Theatre located at 144 South Main as a Landmark Site and the Capitol Theatre located at 50 West 200 South Street as a Landmark Site.

NOW, THEREFORE, be it Ordained by the citizens and voters of Salt Lake City, Utah:

SECTION 1. Designation of Pantages Theatre. That the Utah Pantages Theatre, located at 144 South Main Street, more particularly described on **Exhibit "A"** attached, is hereby established as a Landmark Site as defined in City Code Section 21A.340.020.B.

SECTION 2. Designation of Capitol Theatre. That the Capitol Theatre, located at 50 West Second South Street, more particularly described on **Exhibit "B"** attached, is hereby established as a Landmark Site as defined in City Code Section 21A.340.020.B.

SECTION 3. Emergency Designation. Due to the state of Emergency created by the imminent threat of demolition of the Utah Pantages Theatre, the procedures found in City Code Section 21A.34.020 are hereby suspended and the Utah Pantages Theatre, located at 144 South Main Street, and the Capitol Theatre, located at 50 West 200 South Street, are designated as Landmark Sites through this vote of the citizens of Salt Lake City adopting this ordinance and no other process or procedures for designating a landmark site, found in Section Chapter 21A.34.020, apply or need to be followed to designate the Utah Pantages Theatre and the Capitol Theatre as Landmark Sites.

SECTION 4. Findings qualifying the Theatres as Landmark Sites. The Theatres are the only remaining and best examples of historic theatres in the

downtown area of the City and represent significant elements of the City's history, development patterns, and architecture. Designation of the Theatres as Landmark Sites is in the best interest of the City and achieves a reasonable balance between private property rights and the public interest in preserving the City's cultural, historic, and architectural heritage. The citizens of the City have determined that designation of the Theatres as Landmark Sites is a wise method of preserving a unique element of history important to understanding the history of the area encompassed by the current Salt Lake City corporate boundaries. Designation of the Theatres as Landmark Sites is due to the exceptional importance to the City, State, region, and Nation and imparts high artistic, historic, and cultural values. These Landmark Sites clearly convey a sense of time and place and enable the public to interpret the historic character of the Theatres. Furthermore, the Downtown Community Master Plan, adopted by the City Council in May 2016 after receiving public input specific to the fate of the Utah Pantages Theatre, states as one of its initiatives to "Repurpose the Utah Theater as a cultural facility and activity generator."

SECTION 5. Finding of Compelling, Countervailing, Public Interest. Pursuant to Section 10-9a-504 of the Utah Code, the Voters of Salt Lake City expressly find that the risk of a long term detrimental impact upon the community resulting from demolition of the Utah Pantages Theatre would irreparably harm the City's stock of historically, architecturally, and culturally significant resources and would threaten the City's historic preservation land use planning efforts, and constitutes a compelling, countervailing public interest sufficient to justify the designation of the Utah Pantages Theatre at 144 South Main as a Landmark Site and the nearby Capitol Theatre at 50 West 200 South as Landmark Sites.

SECTION 6. Effective Date. This ordinance shall become effective on the earliest date allowable by Utah law for initiatives and shall be recorded with the Salt Lake City Recorder.

ARGUMENT FOR CITIZEN'S INITIATIVE PROPOSITION:

There are few in Salt Lake City, or from across the state and region, who don't have fond memories of seeing our beloved annual Nutcracker Ballet at the Capitol Theater. We are fortunate to have the opportunity to see it every year at this amazing theater because past leaders had the foresight to save and protect it. The exterior and interior architecture of the theater is a performance in itself, and before any stage performance begins, we have a shared experience across generations past and present, and into the future. The theater has a connection to our city, state, and nation that because of its physical presence, would otherwise be another architectural masterpiece lost to history. Protecting and maintaining it connects us culturally to our past, our present, and our future as a City. We believe it is obvious the Capitol Theater has always been a landmark site in Salt Lake City, even if it hasn't received that formal title until now.

For those who have been fortunate enough to have seen the inside of the Utah Pantages Theater know its landmark nature is also obvious. The historic architecture, stonework, ornate plasterwork, and a grand Tiffany skylight for all to behold, are equally as amazing as the Capitol Theater, if not more so. The Utah Pantages Theater has the same local, regional, and national significance, both historically and culturally. Originally built as a Pantages Theater in 1918, it hosted national acts like Abbot and Costello, Will Rogers, Babe Ruth, and many others who attracted patrons from across the intermountain west. It was arguably the most opulent and expensive theater built by the Pantages Theater chain. As times changed it became the Utah Theater and was Salt Lake City's most spectacular movie palace, famously showing the "Sound of Music" for two years when it was released.

Purchased by the Salt Lake City RDA in 2009, the Utah Pantages Theater was deemed so important to the City and its future that the RDA included it in their own Central Business District Project Area Strategic Plan, with a call to "establish and identify steps to implement a reuse policy for the Utah Theater." In 2016, the year our wonderful Eccles Theater opened, the City Council adopted the Downtown Master Plan which included a call to "Repurpose the Utah Theater as a cultural facility and activity generator." That same master plan makes no such mention of any other building as it does for saving the Utah Pantages Theater. That mandate made by the people of Salt Lake City after widespread public input affirms that we must save and restore the theater.

The Salt Lake City RDA now intends to sell and demolish the Utah Pantages Theater, but both the Capitol and Utah Pantages Theater must be saved and protected for their architectural, historical, and cultural relevance to us and our City's future. Both theaters deserve to be made Salt Lake City "Landmark Sites" by this initiative, saving and protecting them for future generations.

FISAL AND LEGAL IMPACT ESTMATES:

Fiscal Impact Estimate: Salt Lake City's local budget officer, Mary Beth Thompson, estimates that the law proposed by this initiative would not have a significant fiscal impact and would not result in either an increase or decrease in taxes or debt.

Legal Impact Estimate: The proposed rezone which would designate the Utah Theatre and the Capitol Theatre as historic landmark sites is not estimated to create a fiscal impact or savings to the City. The Utah Theatre is owned by the Redevelopment Agency of Salt Lake City, which is under contract to sell the property to a third-party buyer. The intended buyer of the Utah Theatre property might argue that its rights are impacted by the proposed law.
