**ARTICLES OF INCORPORATION  
OF  
JORDAN MEADOWS COMMUNITY COUNCIL**

We, the undersigned natural persons all being of the age of eighteen years or more, acting  
as incorporators under the Utah Non-Profit Corporation and Cooperative Association Act,  
adopt the following Articles of Incorporation for such Corporation:

**ARTICLE I  
NAME**

**ARTICLE II  
DURATION**

The period of duration of this corporation is perpetual.

**ARTICLE III  
PURPOSE**

- (A) The purpose of the Community Council shall be to promote a positive, cultural and physical environment that aids the Community members in obtaining a meaningful, geographic identity and to encourage positive interchange among all members of the community.
- (B) To act and operate exclusively as a nonprofit corporation pursuant to the laws of the State of Utah, and to act and operate as a charitable organization.
- (C) To engage in any and all activities and pursuits, activities and pursuits, and to support or assist such other organizations, as may be reasonably related to the foregoing and following purposes.
  - (i) No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, officers, or other persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered to the corporation and to make payments and distributions in furtherance of the purposes set forth herein:

- (ii) no substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office except as authorized under the Internal Revenue Code of 1954, as amended;
- (iii) the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under 501(c)(3) of the Internal Revenue Code of 1954, as amended (or the corresponding provision of any future United States Internal revenue law).

#### **ARTICLE IV MEMBERS/STOCK**

The corporation shall not have any class of members or stock.

#### **ARTICLE V BY-LAWS**

Provisions for the regulation of the internal affairs of the corporation shall be set forth in the By-Laws.

#### **ARTICLE VI TRUSTEES**

The number of trustees of this Corporation shall be three, or more than three, as fixed from time to time by the By-Laws of the Corporation.
