NOTICE OF PROPOSED WATER RATE ADJUSTMENTS FOR SALT LAKE COUNTY RESIDENTS

What are the proposed rate adjustments?

Salt Lake City Department of Public Utilities protects your water resources, and treats and delivers high-quality drinking water to you. To keep pace with population growth, and to repair and replace aging infrastructure, we are proposing a water rate increase for the coming budget year. Under this proposed budget, the average Salt Lake County household would see a 4% increase – \$2.41 more per month on the average water bill – starting July 2018.

NOTE: Our rate structure is based on volume of water you use. Rates will vary depending on customer type and use (residential, commercial, industrial). We will notify customers of the final water rate adjustment upon Salt Lake City Council budget approval and before rates take effect in July 2018.
