Capitol Hills PRV Replacement Project

Construction of the Capitol Hills PRV Replacement Project is scheduled to start in Spring 2016.

BACKGROUND AND NEED

The purpose of the project is to install a new PRV (pressure reducing valve) vault at the Capitol Hills water tanks. This PRV is necessary to control flow when feeding the tanks. This project will be constructed in its entirety on Salt Lake City property. The only impact to residents will be increased truck traffic during construction.

PUBLIC OUTREACH

SLC Public Utilities staff will be notifying and coordinating with local residents throughout the life of the project. This flyer will be mailed to the residents and discussed in an upcoming community council meeting. CONSTRUCTION IMPACTS

The entirety of the work will take place on Salt Lake City property. Road closures or detours will not be required.

ROAD CLOSURES AND DETOURS

There will be no road closures or detours necessary for this project. Construction crews and equipment will access the site from Girard Avenue.

EASEMENTS

Salt Lake City's infrastructure is constructed on public roads or public property, which are in public rights-of-way. During construction, the Contractor will store supplies only within the public right-of-way or in areas where they have permission.

SAFETY
