5	Street Reconstruction 2026 This annual program funds the vital reconstruction of deteriorated City streets, including street pavement, curb and gutter, sidewalk, drainage improvements, and appropriate bicycle, pedestrian, and transit access improvements.	\$4,390,676
6	700 North Repaving & Enhancements Repave the deteriorated street surface on 700 North between Redwood Road and 2200 West and add pedestrian and transit enhancements and safety features.	\$1,680,600
7	Public Way Concrete This annual program addresses deteriorated or defective concrete sidewalks, accessibility ramps, curb and gutter, retaining walls, etc., in the public way.	\$750,000
10	Bridge Preservation Program This annual program addresses needed bridge repairs and routine maintenance.	\$1,000,000
16	Street Overlays 2026 This annual program funds City street overlays, which may include mill and overlay of street pavement, spot curb and gutter and sidewalk replacement, drainage improvements, and appropriate bicycle and pedestrian access enhancements.	\$3,500,000
20	1200 East Curb/Gutter/Sidewalk & Repave Street Funding will be used to repave 1200 East between Crandall Ave and Zenith Ave and install a curb and gutter on the east side of the road and a curb, gutter, and sidewalk on the west side.	\$303,000

17	Jordan Park Skatepark Expansion This funding is for a study and design of an expansion of the Jordan Park Skatepark.	\$90,000
22	Sport Court Replacement This project will replace or significantly rehabilitate one of Salt Lake City's concrete or asphalt courts used for tennis, pickleball, basketball, and other activities.	\$630,000
23	Playground Replacements Funding will be used to replace or upgrade playground equipment and surfacing that have reached the end of their safe and serviceable life at one park.	\$385,000
28	Riverside Basketball Court Renovation This project aims to enhance the Riverside Park basketball court by updating the aesthetics and adding amenities to make it more user-friendly.	\$530,000
44	Event Infrastructure & Pavilion Replacements for City Parks This funding will be used for essential event and gathering infrastructure to transform several parks into vibrant hubs for community gatherings and public events.	\$2,597,000
45	Playground Shade This project will install shade cloths or sails over up to five existing playgrounds.	\$500,000
48	Rose Park Lane Beautification, Trail, and Safety Improvements This project will replace and improve the quality of the Rose Park Lane trail, and add irrigation, plantings, and trees.	\$680,000
50	Concord Street to Alzheimer's Park Jordan River Cleanup This project aims to improve access to and near the Jordan River, enhance safety and care of the City's property, and promote more positive activity along the river.	\$480,000
57	Civic Center Implementation This funding will be used to help implement and begin construction on strategic segments of Salt Lake City's Civic Center as early as 2026.	\$3,000,000

18	GREENbike Rack Replacements This is a federal funding match to replace old, rusting, falling-apart GREENbike stations and corrals. GREENbike is SLC's bike share system.	\$100,000
19	Livable Streets Program 2026 This citywide program implements traffic calming improvements on local, neighborhood streets in the areas most in need. This funding is for three zones.	\$2,000,000
21	Pedestrian Safety / HAWK at Richmond Street & Zenith Avenue This funding is for a HAWK signal at Zenith Avenue's crossing of Richmond Street.	\$500,000
24	Central City 600 East Byway Safety Improvements This project will improve safety on 600 East between 900 South and South Temple by installing traffic calming, enhancing walking and biking crossings, and upgrading bike lanes at key locations.	\$855,724
41	Glendale Traffic Calming This project will implement traffic calming measures and improvements in the Glendale neighborhood to enhance pedestrian and cyclist safety.	\$76,118
