The definition of what is considered "affordable' is what needs to be addressed and changed as soon as possible. Currently, it being at 80% AMI is frankly ridiculous, considering the AMI is usually shown to be at least 60k, sometimes exceeding 70k. This is such a load of b.s. because you're taking the exceptionally wealthy people and grouping them in with folks that are making hardly anything, and pretending there is actually some sort of middle ground they can meet in (the median). To truly meet the needs in terms of affordability in rent, you must reduce what is considered "affordable" in your definitions and policies from 80% down to 30%. The council and this year's budget, the way it is written, is incentivizing landlords and developers, both predatory professions by nature, for essentially not doing anything, except accepting slightly less money for owning property. There is nothing in the incentive program that demands that landlords/developers must make necessary improvements to properties, nor is there anything about required maintenance. And there should be! It is shameful on them, and the City Council, for not doing more to address inequities in this City, especially when some have so much, and many have so little. Please do take and use the \$6 million, but get back to public meetings, public hearings, and discuss how you will get "affordability" on track to reflect what is actually affordable for most people in need, and not just make it about any given area's "median income". I have carefully read the Ballpark Station Area Plan as well as the letter from Amy Hawkins, Chair, of the Ballpark Community Council related to this matter

The plan contains several admirable elements regarding pedestrian and bicycle mobility and safety. Enhancing the social and shopping scene around the park could add a nice vibe to the area and turn it into a very desirable regional destination. Park green spaces, a library and community center would be welcomed additions if they materialize.

But as Amy so correctly pointed out, unless crime is addressed and curtailed, the desired outcome may never be achieved – even with all the new amenities.

The Ballpark Future Land Use map is a window into how the city wants to transform this westside neighborhood. Besides crime, Ballpark is struggling to hold on to its single-family homes. Home ownership stands at only 15% -- which is the lowest of any neighborhood in Salt Lake. If this plan is adopted even more homes will be lost.

The plan's designers make their intentions clear: "This area is appropriate for the highest densities allowed in Urban Station Areas." What does that mean? Construction of buildings 8-10 stories high – which currently are not found near the Ballpark or the Heart of the Ballpark.

Homes will be lost on the State Street corridor, the Main Street corridor and especially in the area northwest of the ballpark designated as the "Jefferson Park Mixed-Use Area." The city received news in the July "Thriving in Place" report that housing displacement is at an all-time high in Salt Lake. This plan will force more people out of existing homes and rental units. Does the loss of more existing housing send a baffling mixed message from the city?

So-called neighborhoods – what's left of them – will be designated for apartments and units 5-7 stories high. With a massive influx of apartments, Ballpark will become even more rentercentric.

A respected publication called *Governing*, examined several renter-centric cities and learned that renters "require a different set of resources than homeowners." When other variables are controlled for, neighborhoods with more renters had higher rates of graffiti and noise complaints which goes to Amy's point about safety.

The Ballpark Station Area Plan seems like a high risk-reward concept. The Salt Lake Bees play 144 games, only half of which are in Salt Lake. That's 293 days with no action in the ballpark – except for occasional college games and maybe some concerts.

Planners are hedging their bets that all the new esthetics and street activities will act as a magnet for daytime and nighttime guests and residents year-round. However, someone looking for a fun night out, a place to hang with friends, grab lunch, dinner, drinks, snacks, window-shop or go for stroll will not go to a place known more for its crime and murders than cool restaurants or bars.

You won't be able to build enough streetlights, streetscape, or apartment buildings to mask the reality of what the crime element brings into Ballpark and the city's inability to control it. Ballpark has one of the highest concentrations of crime in the city. The Gail Miller homeless Resource Center had 819 calls to police last year and there were high police call rates to four other locations in Ballpark -- the Jefferson School Apartments (637 calls), the Park Vue Apartments (515 calls), Palmer Court (1,053 calls) and The Towers on Main (259 calls). These five facilities represent half of the Top 10 calls made to SLCPD in 2021 in the Liberty District.

How much more evidence does this City Council need before it recognizes that crime is not just a problem in Ballpark, it's an out-of-control problem? Add the VOA Youth Shelter (255 calls) on the other side of 900 South, which some consider technically part of Ballpark, and you have additional reports of crime.

In good conscience, does the City Council think that without a more effective plan to curb crime, the Ballpark Station Plan will make a difference?

Lastly, with a new TRAX station being considered along 1700 south, a new TRAX spur in the northwest corner of Ballpark, and more frequent bus service, Ballpark will look and feel more like a mere transportation hub than a place to call home.

Listen to what Amy said in her letter to the Planning Commission: five of the nine Ballpark residents who served on the Steering Committee for the Ballpark Area Station Plan have moved away and another resigned from the Central 9th Community Council. Residents are leaving Ballpark in search of safety. How many more will leave before the city takes appropriate action to curb crime?
