I will preface these comments by saying that I enjoy this neighborhood and appreciate the efforts of our city council that make Salt Lake City a great place to live. My concern is with offleash dogs, something I virtually never experienced in South Salt Lake or Liberty Wells despite taking my own two dogs for runs and walks in those neighborhoods every day for the several years I lived there. By contrast, I have observed a significant number of loose dogs in my new neighborhood, and unfortunately, a lot of those dogs are not well-trained and cannot be trusted to stay within the boundaries of their owners' properties. I have neighbors whose multiple dogs are never leashed and frequently run up the street out of control or intrude into my yard, despite my attempts to communicate with them that this is a problem. I have neighbors whose dogs have chased my dogs from 30+ feet away. Just in the past week, my two dogs have been approached — and not always politely — by at least five dogs, the majority of which left their own properties to pursue us. My dogs, while leashed, have even been attacked by an off-leash dog in Sugarhouse Park, an incidence which I reported to SLCo Animal Control, who were seemingly powerless to do anything about the attack — even to simply enforce the leash laws, which would have ensured that such a dog attack was far less likely. Like most dogs, my dogs do not appreciate being approached by unfamiliar off-leash dogs. I have employed extensive training to help my dogs handle this stress, but ultimately, there are leash laws in the city, and those laws should be enforced. It is my right to enjoy our public spaces without the constant fear that a neighbor's unleashed dog will run into my dogs' space and potentially cause a fight. I understand that budgets are limited and that resources can only be stretched so far, but is there anything that can be done? It

Reserving so much scarce space for cars also decreases housing affordability because they take up so much space. 2) Businesses are going to choose to locate away from the downtown core and likely outside of SLC altogether which will substantilly reduce our long-term productivity and the availability of high-quality jobs for our residents. When businesses tell us that they need more parking for their downtown offices, I understand why they are saying this and they're right! RE: Firearms in Homeless Shelters

Dear Salt Lake City Mayor and City Council Members,

It is our understanding that Salt Lake City leadership is considering the adoption of the *53-5a-103.5*. *Firearm regulation in homeless shelters* with language that would not differentiate between government owned and operated facilities and privately owned and operated facilities. Shelter the Homeless, The Road Home, and Volunteers of America Utah are opposed to including privately owned shelters in the ordinance and we respectfully submit the following feedback to substantiate this position.

With regard to the language in the Salt Lake City proposed ordinance adopting standards pertinent to temporary and permanent homeless shelters in Section 2k, the following process of storing firearms would prove problematic to shelter operations:

Visible signage at all public entrances indicating that firearms are not permitted inside the homeless shelter. A means of detecting firearms at all public entrances and the plan to ensure an individual is physically present at all entrances when the public entrance is in use. A secure storage area for a firearm for clients of the shelter but also clear policies to not collect information on the firearm while in storage at shelter. An abandonment plan if a firearm is left at the shelter for more than 7 days, process to relinquish to a law enforcement agency for disposal.

We understand this regulation is based on the State legislation below, which is only applicable to State or municipality owned resource centers.

As owners and operators of the Salt Lake County resource centers, we are adamantly opposed to the storage and handling of firearms by resource center staff. Shelter teams are not licensed, insured, or trained to handle firearms, and we do not plan to require this of our staff. There is also imminent risk and potential lethal danger when returning a loaded firearm or firearm and ammunition to an individual who may have just been exited from a resource center and may decrease the number of people willing to work as employees in such a program and increase the fear of people seeking shelter. In our extensive history of operating shelters and residential programs, it is clear to us that guns have no place in shelters where we are serving highly vulnerable individuals. We have always banned firearms in the facilities we operate and will continue to do so.

If this language is left in as a requirement for privately owned shelter facilities, firearms would need to be handled exclusively by outside private security, which would require additional funding for specialty training and certification of the security personnel. We respectfully request that you weigh these concerns as you consider implementation of this regulation. Please don't hesitate to contact us with any questions.
