I am a passionate birdwatcher here in SLC and would like to bring your attention to the Lights Out program, which can benefit birds and also save our building energy and money. Every year, billions of birds migrate north in the spring and south in the fall, often flying at night-navigating with the night sky. However, bright artificial lights and sky glow from big cities can disorient them, causing them to collide with buildings or windows. This confusion and exhaustion can lead to vulnerability to other urban threats. Dozens of species, including priority species such as the Allen's Hummingbird, Wood Thrush, and Golden-winged Warbler, are affected by this problem. Fortunately, a simple act of turning off lights can help birds navigate our environment and protect them from unnecessary harm. The Audubon's Lights Out program is a national effort to reduce this problem, and participating in this program can make a significant difference. For example, in a landmark study conducted by the Field Museum in Chicago, turning off lights in one building reduced the number of birds killed there by over 80 percent. I urge you to participate in Lights Out by turning off unnecessary lighting, putting necessary lighting on timers or using motion sensors, making sure external lighting is down shielded, and dimming or extinguishing lobby or atrium lighting, particularly between the hours of midnight and sunrise and during spring and fall migration periods (April/May and September/October). In addition to helping birds, these efforts have the additional benefits of reducing energy usage and saving money. Thank you for considering this request. If you can make these simple changes in your building or buildings, you can truly have a positive impact on the birds that share our community. Source of the Peace and the Right to Safety and Security Safety and Security Safety and Security Council Member Mano and Interested Parties, We are writing to describe a neighborhood incident that occurred Saturday, May 13, 2023: At 1:00 PM on Saturday our neighbors to the west, tenants in a rental house at REDACTEO South, were actively setting up for a large party. The set-up included amplified music, drums, and acoustic instruments. We were never informed of this event beforehand. We preemptively contacted the landlord and told him of our objections to amplified music, drums, and apparently an open invitation to a large crowd. The landlord told us that he would contact the tenants and "find out what's going on." One of the tenants appeared in our driveway and informed us that the were proceeding with the party but would not activate the amplifiers. He also informed us that he had missed the City's permitting window for amplified music, which we doubted at the time. The tenant who talked to us was abrupt and hostile. Over the course of the next 10 hours, a rotating group of at least 50 to 75 people circulated and the party became increasingly loud, with attendees in our yard and cars periodically blocking our driveway. Other than the three residents of the house, we had no idea who any of these people were - were they hostile, armed, or intent on property damage? Amplified music, banjos, drums, and other instruments were played at such a loud volume that we were driven from our house at REDACTED South due to the deafening noise. We contacted the Salt Lake City Police Department repeatedly, described this situation, and asked for assistance because we are two elderity gay men who are defenseless against an onslaught of at least 50 thirty year olds. The police finally arrived at 10:30 PM after 5 of our phone calls asking for help, spoke to several party attendees, and left after about 5 minutes. The party resumed, at full Volume for another hour and a half, as soon as the police ending the protect or stop the

It does a lot to make us question if Councilwoman Fowler is really owning her mistake and if the Council and mayor are taking this issue as seriously as they should b
