It has no place in our community and will not be tolerated. I noticed the crude symbols and words late Sunday morning as I was walking my nephew's dog. Bonneville Elementary is a beloved place in our community and should always be welcoming and safe for all students. >> Let me offer some insights about potential perpetrators. For years, groups of unruly teenagers have gathered at the school at night causing all kinds of problems — throwing water balloons, pumpkins and other projectiles at cars. About a week ago a group of boys stood near the road ramp on the south side of the school and threw small, plastic containers full of coffee creamers at cars. The debris was all over the street and sidewalk the next morning. >> Sometimes these groups of young boys stand in the busy 1900 East roadway trying to stop traffic or dangerously running alongside cars, chasing them or harassing drivers. I have complained in the past about these problems to the police and, in one instance, the police came and said I was just making it all up — even though the teens were right there just roaming around. I even captured video of their reckless acts. I've watched a few aggravated drivers stop their cars and have confrontations with these gangs — with shouting and chasing. During July these kids always set off fireworks at the school — even though it's illegal. >> Were members of this group involved in the weekend's mischief? Or was this an outlier? I hope your team of detectives can find and prosecute those responsible. UOLs purchase of the land at the base of Little Cottonwood Canyon was one of those efforts. About 2 years ago UOL met the son of the Turvilles who has been settling affairs for his family. We had some good discussions and long story short, UOL wrote a grant to the Utah Office of Outdoor Rec and subsequently obtained the majority of the funding, with SLC also allocating funding. I am a resident in District 7 but I was impressed by your comments earlier today at the inauguration ceremonies at the Downtown Library. I am an avid bicyclist and supportive of efforts to increase bicycle usage in lieu of automobiles. So, I appreciate the city's recent efforts to implement bicycle lanes and the Mayor's proposal to offer rebates for eBike purchases (I do not know the fate of that proposal.) However, a central aspect of the burgeoning and necessary bicycle culture is perennially neglected adequate bicycle parking. It is a major concern and often a blocking issue for bicycling in many circumstances that secure, safe, and convenient bike parking is all but absent in our city. I have been studying this issue for the past year. I have canvassed around 100 cyclist-shoppers at the Downtown Farmer's Market and photographed many "bike racks" with which I am assembling an expose to prove my point. Too often, planners and designers simply throw some odd contraption on the curb and call it a bike rack with no consultation with bicyclists and no realistic accommodation of their needs. I have compiled a list of desirable features of a truly good bicycle parking facility. I am also Vice Chair of the Board of Directors of Wasatch Community Market and have been working with our property owner to consider including such a facility in the renovated landscaping of the Milk Block, where our prospective storefront will be located. My hope is that this could be a prototype for other such installations throughout the city. I have already discussed this with the Mayor's liaison for my District and have proposed in person that the City Council set aside supportive funds. I would be interested in discussing this further with you and/or your own liaison. My second issue, to which you also alluded in your speech, with notable audience response, was "burying the train tracks," by which I am assuming you are referring to the recent proposal to reroute the main through-town rail lines unde

Councilmember Wharton made a comment about the Station Center name being too generic and easy to confuse with other projects (especially for developers), and so I thought I would throw some ideas into the ring (hopefully better than Al-generated ones): • "The Crossroads" - reference to city nickname and geography • "Utah Central" - identifies it as the premiere TOD project of the state • "The Depot" - reference to the Rio Grande Depot and the Depot District • "The Rio Blocks" or "Depot Blocks" - same as previous • "Re-District" or "Ri-District" - portmanteau of "redevelopment" or "Rio" and "district" • "Grande Central" - ok, this one is a little tongue-in-cheek Moving on from names: one thing that I did not see addressed in this version of the concept was connectivity through and around the Rio Grande Depot itself. I think it's absolutely critical for the success of this project to make it easier for people, cyclists, and even cars to get from one side of the Depot to the other. Right now, it is comically difficult. Also, unlike some in the local urbanist media, I don't think cars necessarily have to be completely removed from 300 S to make a good pedestrian experience.
