Apparently this is an effort from the City to encourage and/or reward adoption of EV's, which contribute less to the terrible pollution in the City. I installed the permit in the back window of my vehicle, exactly as instructed. However, despite this, yesterday I received a \$38 citation when I attempted to park in a SLC metered stall for one hour in the morning. When I nicely appealed the erroneous citation, an unknown hearing officer stated: "AFTER REVIEWING ALL THE INFORMATION FROM BOTH PARTIES AS WELL AS THE PHOTOS IN THE MATTER, WE HAVE DETERMINED THIS IS A VALID CITATION AND WOULD NOT BE ABLE TO DISMISS. YOU MUST HAVE AND PROPERLY DISPLAY A VALID GREEN STICKER TO PARK AT METERS FOR FREE FOR UP TO 2 HOURS. YOU HAVE 7 DAYS TO PROVIDE US PROOF YOU HAVE CORRECTED YOUR FAILURE TO DISPLAY VIOLATION OF YOUR PERMIT AND WE WILL REDUCE TO 10.00 YOU MUST SEND A PICTURE OF YOUR STICKER CORRECTLY ATTACHED TO THE REAR WINDOW IN THE PROPER LOCATION TO HEARINGS@SLC.GOV AND WE WILL REDUCE THE FINE AMOUNT." None of the above is true. My sticker was properly placed on my vehicle, as per the attached pictures. It has always been there. My vehicle is a hatchback and the sticker may not be immediately visible to inattentive observers. The initial picture taken by the parking ticket attendant is from far away, but the sticker is nonetheless evident even in the parking ticket attendant's photo. I am not sure that any of this process is the best use of time for city employees or for me. If the City wants to erroneously give tickets to people participating in its Green Vehicles program, then maybe consider just disbanding the program? I ask that the City please advise me as to all further appellate rights. If necessary I will pay the full citation and then sue the City for misrepresenting the nature of the Green Vehicles program.
