Two summers ago, at REDACTED, Blatch's Backyard BBQ started up its business in a house for sale in the historic section of Salt Lake City. Because of Utah's COVID-era regulations allowing home chefs to sell their foo this business received their permit without any input from nearby neighbors on what was being placed in the middle of a residential neighborhood. As in the past, when a resident wanted to add on to their house or make it taller, a notice on when and where the meeting would take place would be distributed around the neighborhood on those being affected. I have never seen such required paperwork. This business burn firewood and this result in the neighborhood filling up with varying degrees of smoke and soot in the air. This is especially harmful where we are close to inversion status. There is an apartment building next door to the business which in the summer when the residents turn on their air conditioners they bring that smoke and soot into their apartments. If we are concerned about air pollution in Salt Lake City, why isn't this business required at least to use propane instead of burning wood? If the lower avenue residents burned wood in there barbecue cokers instead of using propane the air quality would be very unhealthy for sensitive groups including the elderly, asthmatics, diabetics, and hea and lung people. So I ask again, how did this business get the ok from the Salt Lake Business Community withor going through proper procedures? If you don't live in this area, then I suggest you take a walk between 5 and 7 o Wednesdays and Fridays and smell the air near this business. RE: Mixed-Use Zoning Consolidation proposal

Dear Council Members:

Blue Beacon has operated in Salt Lake City since 1992. Our location at 2020 S 900 W is a long-term business that we plan to operate well into the future. Our organization understands and appreciates the city's desire to consolidate the zoning code to better serve its citizens as well as provide planning for the future trajectory Salt Lake City. We support this work but have some concerns about how the implementation will affect existing businesses within the new zoning codes and perhaps lead to unintended consequences for both the city and the neighborhood.

Our company experienced the adoption of new zoning codes. It led to a difficult situation that we can provide as an example of unintended consequences that are not hypothetical. Blue Beacon owned a 100-year-old historic building in Kansas City, MO. It has operated as a hotel for over 50 years in the top tier of all Kansas City hotels. In 2023 we decided to sell the hotel, we found that 10 years before the city went through a process very similar to Salt Lake City. The hotel became a nonconforming use under the new code. No changes in the hotel's use, design, footprint, or operation had changed, and they were not going to change in the sale. We spent nine months and over six figures of expenses in order to meet the updated zoning code before the transaction could close.

We foresee this situation and possibly other circumstances occurring in Salt Lake City for existing businesses that become nonconforming uses under the new zoning code. If it becomes an expensive proposition to make investment into existing businesses because they are forced to meet the requirements under the new code, business owners may neglect making improvements or expansions to their properties. When reinvestment into improvements fails to make economic sense for a business, it often leads to dilapidated property and degradation of the neighborhood, something I'm sure we all want to avoid. It also could slow economic growth as existing businesses work through the bureaucratic process.

Our request to city staff and Council members is to consider grandfathering existing businesses under the previous zoning provisions.

4/27/2025 7:39	Scott Narus	Public Utilities budget and rate plan for 2025-26	Last year I presented our HOA's concerns with the Public Utilities rate plan, in particular the new stabilization fees that treated our small HOA in an inequitable manner and had a severe impact on our finances. We were finally able to resolve the issue after several months of discussion with the City. Because we weren't aware of the new rate plan until after it went into effect in July 2025 we unfortunately had to pay the higher fees for several months until the issue was resolved. I'm hoping we can get ahead of our concern with another rate change for 2025-26, in particular by eliminating the stabilization fees and replacing them more focus on water usage, and by more equitably treating how water usage is charged across various customers. Using historical information about our HOA's water usage, we estimate that the new rate structure will save us approximately \$500 per year on water usage. But the new seter rate structure has changed to adversely effect multi-family organizations like our HOA (where one water meter serves a collection of homes) by using water usage year-round to compute sewer charges. But multi-family organizations like our single-family homes to use their average Winter water usage to compute sewer charges. Because we use significantly more water in non-Winter months for irrigation of our landscape, our water usage is up to 6 to 7 times higher in the Summer months. Using our historical water usage, this will equate to an estimated increase of \$4500 per year in our sewer charges, or about \$6000 more than what we would pay if were charged using the new rate proposals for an equivalent number of single-family homes. Because all our irrigation water never ends up in the sewer, it seems highly inequitable for us to be charged a sewer fee for this water when single-family homes are not charged sewer fees for their irrigation water use. I will be presenting our concerns at the City Council meeting on May 20, but I'm hoping we can receive some feedback on this issue before then.

I have two complaints about this: One, I have to park on the street and it is unfeasible to expect me to move my car every two days; two, the cost of the tow was exorbitant and an undue financial burden. Where I live I do not have off-street parking, therefore I have to park on the street. I was on a trip and left my car parked on the street while I was gone. However, it was not in front of anyone's home and parked in an area rarely used by other cars (intentionally, to not take space where it is needed). There is plenty of off-street parking on my street (Westminster Ave). I feel that if anything there should be a residence permit for vehicles to park on the street without a time limit as I am sure there are many city residents in my situation, without off-street parking as an option. I do not drive much, therefore it is an unnecessary burden to have to get in my car every other day and move it up a spot to avoid violating city ordinance. I also feel that in general the parking limit of two days is much too short. My car was cited (\$38 fee) and then promptly towed by CarTow. There was a warning left on the car two days before it was cited and towed, however as I was on a trip I did not see the warning. Luckily my partner noticed that the car was no longer on the street and discovered that it had been towed only two days after and was able to pick it up with a notarized email to avoid further storage costs. The cost of the tow and car storage fees were §360. Thus the whole ordeal cost around \$400. My monthly rent is around \$465, I am finishing grad school and therefore do not have a lot of income. \$400 is almost my entire monthly rent payment and this cost feels like an exorbitant burden. I have had my car towed before in Washington DC for accidentally parking in a school loading area, and as I recall it was only around \$

To Whom it may concern, It is unfortunate that the SLC Police Department (SLC PD) continues to have a hands off approach with the homeless population on the Westside of SLC; new leadership continues to uphold Mayor Mendenhall's feckless homeless policies. Sunday morning I passed the DAB Utah Liquor Store #13 on North Temple Ave while making my way to the Eastside of SLC. I noticed a white with black lettering SLC PD patrol vehicle parked in the liquor store's parking lot; ≤ 25 yards east of the liquor store is the Jordan River Trailer Gadsby Trailhead parking lot. As the pictures below document, there were two homeless people sleeping at the trailhead parking lot. It is unfortunate the SLC PD takes a reactive approach when dealing with the homeless population on the Westside —again, a reflection of the Mayor's feckless homeless policies. Why do I say this, I had to call the SLC dispatch and inform them that there were two homeless people sleeping at the park next to the Jordan River, and there was a SLC PD patrol vehicle at the State Liquor store parking lot next to the park. This statement can be verified with the patrol vehicles's GPS tracking system, the phone call I made to the SLC dispatch, and the radio response from the patrol officer to the SLC dispatch. As I was taking the below photos, the patrol sergeant arrived and began dealing with the sleeping vagrants. If I would not have made the call to the SLC dispatch, the SLC PD sergeant would not have engaged the two homeless people sleeping in/at the Gadsby Trailhead / park. The officer should be parked in the parking lot of the Gadsby Trailhead; all the while, making his presence known to the community then in a parking lot of a closed business. He had several concerns about utility rates and about garbage collection. Below are the main points of our conversation. Passing along the comment along for your consideration. Thank you, Austin Kimmel Mr. Pulver mentioned that utilities represent his highest monthly expense. While he expressed dissatisfaction with the stabilization fee, I informed him this fee is proposed for elimination in FY26. He believes he's paying for stormwater services that aren't being properly delivered, noting that he frequently clears the storm drain near his home himself. He's frustrated with the Sustainability department's practice of attaching flyers to bins in his neighborhood. He feels this happens too frequently and suggests that physically moving incorrectly sorted waste to the appropriate bin would be more effective than leaving notices. Mr. Pulver has already spoken with Utilities staff but reached out to Council as the Council considers the budget.

			REDACTED. I want to start by informing you of the honor and respect I have for you taking a position of leadership
			for the city. I work in the financial services sector as a licensed Investment Specialist. As someone who is also in
			the "people" business, I can only imagine the nonsense you might experience as a government representative. I
			am reaching out to you to express frustration with a recent decision the council made regarding artificial turf. For
			context, earlier this week my family received a door-hanger from Angela Porter of Civil Enforcement citing that our
			home was in violation of the following codes: 21A.48.080B.4 21A.62.040 We had purchased the home with
			artificial turf on the parking strip and front yard. When we purchased the home, I can recall that it was disclosed to
			us that the city was not a fan of it on the parking strip. But I thought it was just that. I'll take accountability there
			and admit I should've looked into it further. Now I've taken some time to research this topic more. It seems that
			artificial turf has been banned in Salt Lake City since the 1990's and that decision was reinforced last year. We
			have since been told by civil enforcement that if we do not remove the turf by August or September of this year, we
			will be fined \$25 per day. I'm not convinced the city will make an exception for our case so I've gone ahead and
			removed the turf. But my frustration lies in the negative experience we've endured and with the grounds the
			council has apparently made this decision on. As I understand it, the council believes that artificial turf is harmful
			to the environment. It contains a variety of damaging substances such as heavy metals, carcinogens,
			microplastics and/or more specifically SVOCs (semi-volatile organic compounds) and PFAs (per- and
			polyfluoroalkyl substances). There's a concern that there are microplastics that run off into the water supply. It's
			argued that turf causes substantial heat to rise from the ground and into the air. Angela also informed me that it
			harms the organisms in the ground. I want to know how the council came to this decision. What studies has your
			team reviewed? From what I gather, the evidence used to make the claim 'artificial turf is harmful' is actually
			inconclusive. The city hasn't even offered to test my yard for the molecules of concern. You shouldn't make
			significant decisions like this on an unclear basis. As a result, I'm convinced the council is wrong and this decision
			is an overreach into my boundaries as a property owner. Furthermore, the ordinances still allow me to have
			artificial turf in my backyard. Some cities have the same ordinances as SLC but others don't. At a federal level, the
			evidence is still inconclusive. If artificial turf is truly as harmful to the environment as your team believes it to be, then you should strongly consider banning the material in all forms at all locations. Otherwise, the decision
			should be repealed. Utah faces significant water resource challenges and I feel that my artificial turf was an
			aesthetically pleasing way to do my part in being mindful of our elements.

Approximately 30 houses on our street share 10 of the historic street lamps on the street. I was thrilled when LED lighting started coming out since it is less expensive and bulbs last much longer and I felt our costs would go way down. Eventually the city added the bill to the water/sewer bill and for the last few years I have paid attention to the dollar amount we are charged to keep one street light going and am gobsmacked at how much we pay. Between the 3 houses every month we pay between \$65-\$70 a month. That seems way too high when you think that adds up to over \$700 a year for one small bit of lighting from one street lamp. Individually my personal costs are between \$20-30 a month so my figures I feel are low since 3 homes pay for one lamp post (30 homes sharing 10 lamp posts). Today I saw that y'all are going to raise the prices of water, sewer, and street lighting this summer. These street lamps are old and the cost to the residents who have paid for these street lamps for decades most certainly have paid for these lights 10x's over through the years. I don't understand why we are being charged so much for one light bulb. I'm 65 years old and the sole wage earner in my family. Over the years it gets harder and harder to pay these exorbitant bills for utilities. I even where coats inside in the winter to keep my gas bill for heat down and have to douse my pajamas in water before going to bed to help keep me cool enough to sleep during the summer to keep my central air electric bills down. Is there anything I have the power to do to keep my bills from going up even further? Lynda

(Attached to this email, you will find 2 water service bills I have paid. One for January 2023 and one for January 2025 that illustrate the doubling amount of basic rates within a 2-year period). I am PRIMARILY concerned about the rapidly increases to the basic cost of access to potable water. The lowest of the lowest rate necessary for a household to maintain a basic level of sanitation has more than doubled in the past 2 years: JANURAY 2023; \$26.68 JANUARY 2025; \$57.03 Reviewing the proposed changes in the 2025/26 budget, it is clear that this cost is bound to continue to increase at a rate that far outgains the ability of those in fixed income or lower income households to meet the most basic level of sanitation, putting in danger the community's health and safety at large. It is for this reason that 1 this council must consider amending the proposed rate changes and make it a priority to maintain - perhaps even LOWER the basic cost of accessing water. This means reviewing the Fixed Charges (2 different charges) and Block 1 for its residential and multi-family customers. If additional revenue is needed to meet the regulatory expenses required on this service, these increases in revenue must be made through the commercial and higher blocks of water use which are not deemed essential for the safety, health and welfare of the community you represent (and even those you do

Re: Proposed Strong Public Health Messaging to Support Measles Vaccination and Request for Amendment to Salt Lake City FY2025-2026 Budget

Local Public Health Governmental Officers,

This is to request that Salt Lake City Corporation, Salt Lake County, and the Salt Lake City-County Health Department institute a strong early public health messaging campaign with respect to measles MMR vaccination in advance of the increased spread of measles over the summer season. An emergency budget modification to the SLC Mayor's Office of \$10,000 to finance a summer vaccination campaign is requested based on the current national measles outbreak and using a strong visual messaging. I am not a medical expert.

Measles cases have now been detected in ten U.S. States, including nearby California, Colorado, New Mexico and Washington.¹ The U.S. measles outbreak has crossed U.S. borders to Mexico (421 cases) and Canada (804 cases).² Over 30,000 cases have been reported in Europe, principally in Romania (~27,000 cases).³ Salt Lake County and City sit at the intersection of a major east-west and north south freeways that involve over 30 million road trips per year. The Intermountain West international summer tourism season has begun.

Currently, no cases of measles and rubella have been detected in Utah during 2025, and 5 measles cases occurred since 2015.⁴ These factors, along with lower vaccination rates in Utah's Hispanic and minority communities, make it a matter of time and not probability for when cases of this avoidable childhood disease will reach Utah.⁵ A 95% vaccination rate in school age children is needed to induce community immunity sufficient to contain measles.⁶ In 2022, modeling estimates that nationally about 9.1 million children (13.1%) were susceptible measles due to lack of vaccination with a projected increase to about 23% due to continuing pandemic era vaccine hesitancy ().

This is because measles is not SARS-Cov2 or Covid-19 disease. SARS-Cov2 has an R0 of 1.5-6.5, much less than the R0 of 12-18 for measles or up to 12 times that of SARS-2. Measles has a crude case fatality rate in developed countries similar to Covid-19 disease at 0.1%, but measles has a hospitalization rate of 25%.⁷

Federal guidance during 2025 has consisted of mix-messaging. Initially, new HHS Secretary RFK, Jr., officially promoted public health measles guidance that emphasized disproven non-vaccination primary interventions such Vitamin A and cod-liver oil. Vaccination was de-emphasized as an optional second tier intervention choice. In April 2025, RFK, Jr. reversed that position and his personal statements and official CDC policy reinstated vaccination as the primary preventative intervention.⁸ As late as May 2, the HHS Secretary has returned to his misinformation campaign, again claiming that CDC policy prospectively be change to emphasize dis-credited treatments and falsely claiming that the measles vaccine contains tissue fragments from aborted fetuses.⁹

On the state level, the Utah State Legislature passed various anti-vaccination laws in response to Covid-19 pandemic. State laws liberally provide for personal exemptions from child vaccination and-or requiring employees from prohibiting their vaccination status.¹⁰ During the 2024-2025 school year, about 10% of in-person kindergarten students in Utah had an exemption for the MMR vaccine or were

missing documentation to show they are vaccinated against measles, and about 10% all K-12 students in Utah had an exemption to any school-required vaccine.¹¹ The state's child vaccination rate is approximately 90-91% - below the 95% vaccination rate needed to contain measles () – up from 88% during the 2023-2024 season.¹² Those Utah state laws do not restrict local government from conducting their own pro-vaccination public health campaigns that do not align with state-level public health public communication design.

Post-Covid-19 pandemic consensus by the public health community emphasizes positive community engagement and avoiding negative imagery that might promote fear-based disengagement.¹³ That non-confrontational public messaging should be used is not sufficient to meet the potential 2025 endemic measles outbreak.

The vaccination campaigns for measles that most proportionally change public views emphasize the adverse risks and effects of measles.^{14,15} Countering autism disinformation affects little change in public opinions ().

Salt Lake County and Salt Lake City have the summer to encourage MMR vaccination before children concentrate with the beginning of the next primary and secondary school year. Increasing vaccination rates closer to 95% will minimize the human and economic impact of measles and rubella on the County's young children.

Based on the foregoing discussion, the County and City should again take the lead, as they did during the Covid-19 pandemic, in making extra-ordinary efforts to counter federal disinformation about MMR vaccination. Polite community-engagement public health messaging promoting MMR vaccination is not enough to meet the challenges of the 2025 season. A strong worded campaign that uses graphic disease photographs is needed. Even if you disagree with an adverse-effect based public health campaign, the potential for an endemic 2025 measles season justifies the City kicking in an emergency \$10,000.

Madbrook operates its bakery and main offices in a large building located at 375 West Hope Avenue in Salt Lake City. Currently Madbrook is zoned as CG. However, as part of the Planning Commission's proposed zoning changes (the "Proposal"), Madbrook's building will find itself in the MU-11 district. This is concerning because atthough a commercial bakery will continue to be an approved use, the building would potentially become a noncomplying structure under the proposed changes to Section 21A.37.050 of the Municipal Code. As this Proposal has proceeded, Madbrook has become increasingly concerned by the high burden that the new design standards will impose on many of the established buildings along the I-15 corridor. Further, it appears that there is very little, if any, exception or carve out for retailers, manufacturers, and other complying uses, but noncomplying structures unless the local business isn't really a local business, such as Walmart, Costco, and other bigger box retailers. Madbrook therefore remains concerned that the increased standards and minimal exceptions disproportionately affect smaller businesses like Madbrook. Specifically, when developing some of the newer Proposals, the Planning Commission Staff acknowledged "the reality that [certain] grocery stores generally do not meet the regulations to such large commercial noncomplying structures." September 25, 2024 Staff Report at 9. The Staff thus proposed "additions allowance[s]" whereby a grocery store with over 10,000 square feet be allowed expansions of a maximum footprint of 7,500 square feet (a 75% expansion) without the requirement of undergoing Design Review or complying with the Design Standards. Atthough the numbers have changed slightly, the accommodation persists for businesses lucky enough to find themselves in the MU-3 zone, but not those who land in the MU-11 zone. As a result, if the Proposal is passed as currently submitted, Madbrook and

Inequitable Exceptions to Design Standards in Proposed MU Consolidation	The Proposal also discusses the creation of a Transitional Overlay over the zone in which Madbrook's building is located. See id. § 21A.34.030. Buildings in this Overlay may access relaxed design standards if either (1) they implement a series of several landscaping measures or (2) they are a pre-existing "large" retailer with more than 100,000 square feet of floor space. This limited exception that ignores buildings in the I-15 corridor means that businesses that have approved and conforming uses might incur significant demolition and remodeling even under the relaxed standards. However, the largest retailers, such as Walmart – which is across the street from Madbrook and within spitting distance. The Home Depot, and Costco all receive immediate access the relaxed standards just by virtue of their size. In essence, the City would be prioritizing protecting the largest retailers (and not local businesses) from the new requirements – even though those retailers arguably have more resources and capital to do so. This may mean that smaller businesses will have no choice but to move or go out of business, just allowing more lucrative and bigger boxes to fill the void. This is simply unfair. The Proposal's effort to create addition allowances and relaxed standards for some of the businesses that are most affected by the changes is admirable, but in its current state, it creates inequity by hand-selecting only a few favored businesses, in certain parts of the new zones, to benefit from the changes while ignoring similarly-situated businesses that even have approved uses. While there are many walkable areas in Salt Lake City that may benefit from these design onw, without making exceptions, is unfair and robs these owners of their expected return on their investments – both in their real estate and their businesses. Accordingly, we respectfully request that the City Council deny the Proposal in its current state with directions to the Planning Commission to create more equitable exceptions that allow for the same addi
