I live on REDACTED. I've seen people urinating off the roof of a building on the corner of my block (and had to pass that home when walking my dogs). I've had nude young men running across the street from that home to the home next door to me, then vomiting into my driveway. I've been kept awake by extremely loud gatherings late into the night. I've had to pick my way past broken glass, crumpled cans, and, yes, more vomit on the sidewalks in the days (yes, multiple days) after parties. I've seen vulgar, racist, homophobic signage posted on a home around the corner on 400 south during parties. I've had people peeing onto the driveway and vehicles at my rental property (which does NOT conduct such parties) around the corner on 1200 East. I've sometimes felt afraid to walk down the block when the drunkenness gets extreme, and the driving gets reckless. The behavior is offensive and illegal, and frequently the police don't respond within a meaningful timeframe. I've been told it's my fault for living in the university neighborhood, and if I don't like it I should move. My family has owned property and lived in this neighborhood since the mid 1980s. My husband is a university professor; we chose this neighborhood to be within walking distance of his work. We should not be forced to move because of blatantly illegal activity. But we have never felt as assaulted as we have in the past 2-3 years. It just keeps getting worse. Something needs to be done.</p> <p>Thank you for your attempts to make a difference. 8/13/2025 12:46	Jen Colby	Please vote yes to amend Ch 11.14 to authorize a civil fine for unruly parties	<p>Dear Council Members, As a longtime resident of the East Central neighborhood adjacent to the University of Utah, the increase in extremely large, loud, unruly, and often alcohol-fueled parties has been noticeable over time. This may be partly due to more students living on campus and it being a dry campus. Students living in the many rental houses right off campus often host large gatherings on private property that also usually involve alcohol - which is fine if everyone is of age and not drinking to dangerous excess. For students, and from personal experience at that age, that can be well, let's just say misjudged or social pressure overrides better judgment.</p> <p>These parties are often linked to large U of U sporting events, like football games. While I fully support social gatherings and parties and general fun events that are reasonable, these huge parties are a whole different scene. They also tend to be at a handful of known addresses, with absentee landlords who are either unaware or uncaring about the situation. Many residents in the neighborhood have tried direct approaches to ask the hosts to address the noise, chaos, litter, and disturbance to neighbors. To their credit some have done so. This approach will continue. But for other party situations, this is well beyond the scope of resident responsibility, or ability. I therefore support the proposed changes to the Chapter 11.14 section of the ordinance to create a civil enforcement fee structure. While this will not eliminate the issue, it may help engage property owners to address life/safety/noise/party issues created by their tenants on their properties. I also hope the city will better enforce the Good Landlord policy and revoke it for those in violation. Our city councilperson and administrative staff have taken this seriously and worked to listen to the issues and try to find better tools. I appreciate their efforts and support this change. You know where that is -- half a block from the "Civic Center." I cannot imagine what this will do for our traffic and the 200 residents of The Metro attempting to get in and out of the building. We are used to 200 East being blocked off periodically, frustrating our driving south on it to get to 500 South. But we are not used to streams of visitors crossing and sitting near the entrance to our garage. I can see what it's like for The Worthington people trying to get out of their garage day in and day out, worrying about the constant scooters that shoot across the path. It's a matter of time... More than that, though, I believe this city has much bigger problems, and that \$3 million in just its initial investment could be spent on them. The City in Jan 2025 committed \$5 million toward funding deeply affordable housing. Doesn't it make more sense to spend \$8 million (\$5 million plus the Green Loop's \$3 million) to try to solve this seemingly intractable problem? And how about our air quality? I do not know what processes the City could use to help but doesn't because "it doesn't have the money?" What about mental health facilities for these souls that sleep in our doorway or shout their way up and down the street? What about wildfire mitigation in the Foothills and above Federal Heights? It is the City Council's responsibility to address the most pressing issues before it, and not to spend \$3 million (to start) on the Green Loop.</p>
