The Council was updated on Mayor Erin Mendenhall's comprehensive Public Safety Plan, which was released earlier this month in response to an invitation from state leaders. The plan outlines multiple actions and systemic recommendations, including creating approximately 1,000 emergency shelter beds, strengthening collaboration with stakeholders, and increasing visible police presence.
