#### **Ranked Choice Voting**

The Council confirmed that the upcoming municipal election will use the Ranked Choice Voting (R.C.V.) method. The Council's action also confirmed that there will not be a Primary election. Under R.C.V., voters rank the candidates in order of preference. Salt Lake City first participated in R.C.V. without a primary for the 2021 Municipal General Election. Unless state law changes, this will be the last year Salt Lake City can participate in the Alternative Voting Methods Pilot Project.

# **VOTES**

The Council approved the re-establishment of the Salt Lake City Central Improvement Assessment Area to support downtown economic promotion and the area's holiday lighting program. An update on this item was also provided during the Council's Work Session. (Watch)

# **PUBLIC HEARINGS HELD**

The Council held a briefing and provided public input opportunities for a resolution creating of a Public Infrastructure District to facilitate the financing for redevelopment of the Delta Center, entertainment district, and renovation of the Salt Palace. The Council is scheduled to take action at a Special Council Meeting next week. (Watch)

## **BRIEFINGS**

The Council was briefed on the following items during the work session:

- The City's efforts to prepare for possible urban/wildland fires
   and educate residents about fire prevention (Watch)
- 500 and 600 South Grand Boulevards Concept Re-development Project. The project team is in early engagement phases and will work with stakeholders to balance walkability and mobility for vehicles. It will also follow the process and requirements set forth by Senate Bill 195 adopted by the legislature this year. (Watch)
- Budget Amendment No. 5, which includes an increase in security at several Westside parks and around City Hall, fully funding repair of the 400 South bridge over the Jordan River, and additional funding for construction mitigation grants for businesses. (Watch)
